Rules and Regulations

The purpose of Golden Days Pet Grooming & Dog Day Care is to provide a safe, fun, and stimulating environment for dogs during weekday business hours. To ensure the safety and health of your pet and of our other guests, we require all of our guests to comply with the following Rules and Regulations:

AGE: All dogs must be at least 4 months of age or older

SEX: All dogs must be spayed or neutered by 7 months of age

SHOTS: all dogs must have up-to-date vaccinations. Owners must submit written proof that their dogs have current DHLPP and Rabies vaccinations. Kennel Cough vaccination is recommended but not required.

HEALTH: All dogs must be in good health. On admission all dogs must be free from any condition which could potentially jeopardize other guests. In the event your dog needs medical attention while at Dog Day Care every effort will be made to contact your veterinarian. If that is not possible, your dog will be treated as deemed best by the staff.

BEHAVIOR: All dogs must be non-aggressive and not food or toy protective. Owners will need to certify that their dog(s) has/have not harmed or shown any aggressive or threatening behavior toward any person or any other dog(s). A standard admission interview will be conducted prior to acceptance into Dog Day Care.

DAYS AND HOURS: Monday through Friday from 7:00 a.m. to 7:00 p.m. Golden Days Pet Grooming and Dog Day Care is NOT an overnight facility. Your pet may NOT be left here after 7:00 p.m.

DAY CARE RESERVATIONS: Reservations are appreciated but are not mandatory at this time. However, please be advised that due to the growing popularity of Dog Day Care reservations may be required in the future.

Golden Days Pet Grooming & Dog Day Care Health and Temperament Agreement

I understand that I am solely responsible for any harm caused to or by myself or my dog(s) while my dog(s) is/are attending Golden Days Pet Grooming & Dog Day Care. This includes incidents upon the premises or grounds or in, at, or near any entrance or exit when my dog(s) is/are being delivered, removed, or otherwise handled.

I further understand and agree that in admitting my dog(s), Golden Days Pet Grooming & Dog Day Care has relied on my representation that my dog(s) is/are in good health and have not harmed or shown any aggressive or threatening behavior toward any person or any other dog(s).

I further understand and agree that Golden Days Pet Grooming & Dog Day Care, their staff and volunteers will not be liable for any problems that develop provided reasonable care and precautions are followed, and I hereby release them from any liability of any kind whatsoever arising from my dog(s) attendance and participation at Dog Day Care.

I further understand and agree that any problem that develops with my dog(s) will be treated as deemed best by the staff of Golden Days Pet Grooming & Dog Day Care in their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
